1. Introduction

This Creator Agreement ("Agreement") establishes the terms and conditions that apply to users who participate as Creators on the Gudiee marketplace.

This Agreement is between:

Gudiee LLC ("Gudiee," "we," "us," or "our")

and

The Creator ("Creator," "you," or "your")

By registering as a Creator, submitting designs, creating listings, or participating in Creator activities on Gudiee, you agree to this Agreement.

This Agreement supplements the Gudiee Terms of Service and Privacy Policy.

If there is a conflict between this Agreement and the Terms of Service, this Agreement controls only regarding Creator-specific obligations.

2. Creator Role

Creators are individuals or businesses that develop original designs, artwork, concepts, or digital files that may be produced into physical products through Gudiee.

Creators are responsible for:

- Developing original designs.
- Providing accurate product information.
- Ensuring designs are suitable for production.
- Maintaining ownership rights or proper authorization for submitted content.

Creators retain ownership of their designs unless they independently transfer ownership outside of Gudiee.

3. Creator Account Requirements

To participate as a Creator, you must:

- Maintain an active Gudiee account.
- Provide accurate profile information.
- Provide required payment information.
- Provide required tax information when applicable.
- Follow Gudiee marketplace policies.

Creators may participate as individuals or businesses.

Creators are responsible for maintaining accurate account information.

4. Ownership of Creator Designs

Creators retain all ownership rights, title, and interest in designs, artwork, files, and creative works submitted to Gudiee.

Gudiee does not obtain ownership of Creator designs.

Submitting content to Gudiee does not transfer:

- Copyright ownership.
- Trademark ownership.
- Design ownership.
- Commercial rights ownership.

5. License Granted to Gudiee

By submitting designs to Gudiee, Creator grants Gudiee a limited, non-exclusive, worldwide license to use submitted content only as necessary to operate the marketplace.

This license allows Gudiee to:

- Display designs on the Platform.
- Create product listings.
- Market listed products.
- Facilitate production.
- Allow authorized Makers to access production information.
- Complete customer orders.
- Provide marketplace services.

Gudiee may not use Creator designs outside marketplace operations without additional authorization.

6. Original Work Requirement

Creators represent and warrant that:

- They created the submitted designs, or
- They have obtained all necessary rights and permissions to use submitted content.

Creators may not upload designs that:

- Were created by another person without authorization.
- Infringe intellectual property rights.
- Misrepresent ownership.
- Violate third-party rights.

7. AI-Generated Content Policy

Gudiee does not permit AI-generated designs or artwork to be uploaded as Creator submissions.

Creators must verify that:

- Submitted designs were created by them.
- The work is not generated by artificial intelligence.
- The Creator has ownership rights to the submitted work.

Creators may use digital tools, software, and creative applications as part of their design process, but the final submitted design must represent Creator-created work.

8. Design Manufacturability Requirements

Creators are responsible for ensuring submitted designs can reasonably be produced.

Creators must consider:

- Manufacturing method limitations.
- Material requirements.
- Product specifications.
- Production feasibility.

Examples of issues Creators should avoid:

- Designs that cannot physically be manufactured.
- Files missing required production information.
- Designs that create unreasonable production failures.
- Product concepts that do not match available manufacturing methods.

Creators acknowledge that production requirements may vary depending on the Maker and manufacturing process.

9. Listing Accuracy

Creators are responsible for providing accurate listing information, including:

- Product descriptions.
- Images.
- Design details.
- Available options.
- Production requirements.
- Recommended materials.
- Manufacturing instructions.

Creators may not intentionally misrepresent:

- Product capabilities.
- Materials.
- Production methods.
- Expected results.

10. Creator Royalties

Creators determine the royalty amount they wish to earn from each completed product sale.

The Creator royalty is the amount designated by the Creator for each completed order using their design.

Creators acknowledge that:

- Royalty amounts may affect the final product price.
- Buyers are responsible for the final displayed price.
- Gudiee may provide pricing guidance or marketplace recommendations.
- Excessive pricing may affect product competitiveness.

Creator royalties apply only to eligible completed orders.

Creators do not receive royalties from:

- Shipping charges.
- Taxes collected from Buyers.
- Orders that are refunded or canceled before completion.
- Orders removed due to policy violations.

11. Product Pricing Structure

Product prices on Gudiee may include:

- Maker production compensation.
- Creator royalty.
- Gudiee marketplace fees.
- Applicable transaction fees.
- Other applicable charges.

Gudiee determines Maker production compensation for listed products based on production requirements and marketplace operations.

Creators are responsible for selecting their desired royalty amount within Gudiee's available system limits.

12. Creator Payments

Creator earnings are paid through Gudiee's designated payment system.

Creators must provide:

- Accurate payout information.
- Required identity verification information.
- Tax information when required.

Payments may be delayed, withheld, or reviewed due to:

- Fraud investigations.
- Payment disputes.
- Refunds.
- Policy violations.
- Legal requirements.

Creators are responsible for reporting income earned through Gudiee as required by applicable laws.

13. Production File Access

Creators understand that production requires sharing certain information with authorized Makers.

To complete orders, Makers may receive:

- Necessary design files.
- Manufacturing instructions.
- Product specifications.

Makers may only use Creator files to complete authorized Gudiee orders.

Makers may not:

- Sell Creator designs independently.
- Reproduce Creator designs outside Gudiee orders.
- Claim ownership of Creator designs.
- Distribute Creator files.

14. Creator Responsibility During Production

Creators acknowledge that manufacturing outcomes depend partly on the quality and suitability of submitted designs.

Creators are responsible for:

- Providing usable files.
- Providing accurate instructions.
- Avoiding designs that are impossible or impractical to manufacture.
- Updating listings when production requirements change.

If a design repeatedly causes production failures due to Creator-provided issues, Gudiee may:

- Request design updates.
- Temporarily pause the listing.
- Remove the listing.
- Restrict Creator marketplace access.

15. Product Modifications

Makers may make minor production adjustments when necessary to successfully manufacture an order, including:

- Manufacturing tolerances.
- Production adjustments.
- Material substitutions approved by marketplace requirements.

Makers may not materially alter Creator designs without authorization.

Any significant design changes should be reviewed according to Gudiee procedures.

16. Listing Review and Verification

Gudiee may review Creator listings to maintain marketplace quality and trust.

Reviews may include:

- Content review.
- Manufacturing feasibility review.
- Intellectual property review.
- Policy compliance review.

Gudiee does not guarantee that every listing review will identify all issues.

Creators remain responsible for submitted content.

17. Listing Removal

Gudiee may remove or restrict Creator listings when necessary.

Reasons may include:

- AI-generated content.
- Intellectual property concerns.
- Inaccurate information.
- Safety concerns.
- Policy violations.
- Manufacturing issues.
- Customer protection concerns.

Removing a listing does not transfer ownership of the design to Gudiee.

18. Creator Violations

Creator violations may result in:

- Listing removal.
- Warning notices.
- Temporary restrictions.
- Suspension of Creator privileges.
- Account termination.

Repeated violations may result in permanent removal from the Creator program.

Examples include:

- Uploading AI-generated content.
- Uploading stolen designs.
- Misrepresenting ownership.
- Repeated manufacturing failures caused by Creator submissions.
- Manipulating marketplace systems.

19. Appeals Process

Creators may appeal:

- Listing removals.
- Creator role restrictions.
- Account suspensions.

Appeals should include relevant information explaining:

- Why the action should be reconsidered.
- Supporting documentation.
- Corrective actions taken.

Gudiee may review appeals and make final determinations based on marketplace policies, available information, and applicable requirements.

20. Creator Portfolio and Public Information

Creators may choose to display public information through their Gudiee profile.

Public information may include:

- Creator name or business name.
- Profile information.
- Portfolio examples.
- Listed products.
- Marketplace activity.

Creators should only submit information they are comfortable displaying publicly.

21. Creator Marketing

Gudiee may promote Creator products through marketplace marketing activities.

This may include:

- Product discovery pages.
- Social media promotion.
- Marketplace collections.
- Promotional campaigns.

Gudiee's use of Creator listings for marketing remains limited to promoting products available through Gudiee.

Creators retain ownership of their designs.

22. Termination of Creator Participation

Creators may stop participating as a Creator at any time, subject to:

- Existing orders.
- Completed transactions.
- Outstanding payments.
- Legal obligations.

Gudiee may suspend or terminate Creator participation for violations of:

- This Agreement.
- Terms of Service.
- Marketplace policies.
- Applicable laws.

Termination does not affect:

- Completed orders.
- Existing payment obligations.
- Ownership rights.

23. Creator Representations and Warranties

By participating as a Creator on Gudiee, you represent and warrant that:

- You have the legal right to submit your designs and content.
- Your submissions do not violate the rights of others.
- Your listings contain accurate information.
- Your designs comply with Gudiee policies.
- Your submissions are not AI-generated.
- You are responsible for ensuring your designs are suitable for production.

You acknowledge that Gudiee relies on these representations when allowing Creator participation on the Platform.

24. Creator Indemnification

To the extent permitted by law, Creators agree to protect and reimburse Gudiee from claims, damages, losses, liabilities, costs, and expenses arising from Creator activities, including:

- Intellectual property claims related to Creator designs.
- Copyright or trademark disputes.
- Claims caused by inaccurate listings.
- Violations of laws or regulations.
- Misrepresentation of ownership or authorization.

This obligation applies only to matters caused by the Creator's actions, content, or failure to meet responsibilities under this Agreement.

25. Creator Compliance With Laws

Creators are responsible for complying with applicable laws and regulations related to their activities on Gudiee.

This may include:

- Intellectual property laws.
- Business registration requirements.
- Tax obligations.
- Advertising requirements.
- Product-related requirements.

Creators are responsible for obtaining any licenses, permissions, or approvals required for their activities.

26. Relationship Between Gudiee and Creator

Creators participate on Gudiee as independent marketplace participants.

Nothing in this Agreement creates:

- An employment relationship.
- A partnership.
- A joint venture.
- An agency relationship.

Creators are responsible for their own business decisions, obligations, and tax responsibilities.

27. Confidential Information

Creators may receive access to information that is not publicly available, including:

- Maker production information.
- Marketplace performance information.
- Business processes.
- Platform features.

Creators agree not to misuse confidential information obtained through Gudiee.

Confidential information does not include information that:

- Is publicly available.
- Was independently developed.
- Was lawfully received from another source.

28. Marketplace Feedback and Improvements

Creators may provide feedback, suggestions, or ideas regarding Gudiee.

By providing feedback, Creators allow Gudiee to use that feedback to improve the Platform without obligation to compensate the Creator.

Feedback does not transfer ownership of Creator designs or creative works.

29. Changes to Creator Agreement

Gudiee may update this Creator Agreement when necessary to:

- Improve marketplace operations.
- Reflect changes in services.
- Address legal requirements.
- Improve Creator protections.

Material changes may be communicated through reasonable methods.

Continued participation as a Creator after changes become effective constitutes acceptance of the updated Agreement.

30. Governing Law

This Agreement is governed by the laws of the State of Florida, without regard to conflict-of-law principles, except where applicable law requires otherwise.

31. Severability

If any provision of this Agreement is found invalid, unlawful, or unenforceable:

- The remaining provisions remain effective.
- The invalid provision will be modified to the extent necessary where permitted.

32. Entire Agreement

This Creator Agreement, together with:

- Gudiee Terms of Service.
- Gudiee Privacy Policy.
- Marketplace policies.

represents the complete agreement between Gudiee and the Creator regarding Creator participation on the Platform.
